#### Explanatory Notes

The councillor's record of claims has been prepared in accordance with the Local Government (Allowances and Expenses) (Scotland) Regulations 2008 and additional guidance notes as issued by the Scottish Government.

The record includes expenditure incurred directly by the Council on behalf of the Councillor, for example, travel expenses, information services and conference fees if organised by the council.

The following support functions are the responsibility of the Council, and are therefore not included in the above table of figures:-

- Office support facilities at a cost of £25,327.37
- Training and development by in-house providers, including seminars, at no additional cost;
- The provision of insurance in respect of Councillors, including employers and public liability cover, at a cost of £1,422.75
- Accounting for tax and national insurance on the figures quoted above.

Reimbursement of expenses from Outside Bodies refers to the Orkney and Shetland Valuation Joint Board, Orkney Ferries Ltd, Highlands and Islands Police and Fire Boards, Northern Community Justice Authority and HiTrans.

The main changes to the record of claims from the previous year has been the inclusion of information services, such as the provision of mobile phone and broadband services, the cost of which is now recorded as a direct expense for each councillor. These expenses were previously disclosed as part of the explanatory note to this statement.

On a comparable basis the salaries and expenses for the financial year 2007-08 would amount to a total cost of £423,200.77. As such, the total cost of £445,311.85 for the financial year 2008-09 represents an increase of £22,111.08 or 5.22%.
