Any person applying for either of the following:

- A taxi or PHC driver's licence for the first time.
- Renewal of a taxi or PHC driver's licence, for the first time since 1 December 2016\*.

Must submit:

- Completed application form.
- Evidence of Right to Work in the UK.
- 3 identical passport sized photos.
- UK or equivalent European Union driving licence (photocard or older paper version).
- UK driving licence holders – printout of current electronic Driving Licence Summary record held by DVLA available from <https://www.gov.uk/view-driving-licence> or Share Code to permit Licensing officers to view and print information.
- Criminal Record Checks outwith UK, where necessary.
- Medical information where necessary.
- Application fee.

These must be submitted at a **personal interview** prearranged with Licensing staff, who can be contacted by email at [licensing@orkney.gcsx.gov.uk](mailto:licensing@orkney.gcsx.gov.uk) or telephone at 01856873535 extensions 2229 or 2232.

\*Even if you have renewed your taxi or PHC driver's licence on previous occasions before 1 December 2016, you must provide evidence of your right to work in the UK on the first occasion when you submit a renewal application on or after 1 December 2016.

Other applicants for a taxi or PHC driver's licence:

- Must submit the documentation referred to above, except the evidence of Right to Work in the UK.

  - A. Temporary licences (which cannot exceed 6 weeks).
  - B. Certified duplicate or true copy licences.
  - C. Consideration of any material change of circumstances, including premises, vehicles or vessels.
