# Community Consultation on Potential Birsay Improvements



Orkney Islands Council wish to undertake some early consultation with the Birsay Community to get feedback on initial ideas to help improve the issues impacting the Village and the Brough of Birsay car park at the Point of Buckguoy.

#### Issues we are considering as part of the concept work: -

- Management of traffic and parking in the Brough of Birsay car park, including coaches, campervans and other visitors.
- Future-proofing and potential road safety issues.
- Coastal erosion and potential impacts on existing infrastructure.
- Safe and sustainable access to the Brough of Birsay and other local features.
- Outdated toilet facilities within the Village.

As part of investigations into ways to alleviate these and other issues, we have prepared some initial sketch options. These options include ideas for new toilet facilities and consider the capacity and location of parking in the Village, management of coach access alongside local traffic requirements, and long-term access issues to the Brough of Birsay car park. Potential delivery will be dependent on land ownership, funding, and statutory approvals.



# **Birsay Village Car Park**

This sketch focuses around the existing car park in the centre of the village.

- Extension of the existing car park area into the field to the east (approx. 12 more spaces)
- Potential further parking overflow in adjacent field to the north (approx. 20 more spaces)
- Introduction of screen planting between existing house and car park area

- Location of a new toilet block within the car park
- Opportunity to improve the pedestrian link between the car park and the Earl's Palace by creating a paved margin alongside the road
- Opportunity to give pedestrians priority between the car park and the Earl's Palace junction by using a coloured overlay on the road surface to denote a traffic calmed / pedestrian area




# Field to South of St. Magnus House / East of Earl's Palace - New Car Park & Coach Turning Area

This sketch focuses on the field which lies to the south of St Magnus House, accessed from the main road to the east of the Earl's Palace.

- Introduction of a junction off the main road immediately to the west of the St Magnus House garden.
- Creation of a large car park area (approx. 42 car spaces,
  4 campervan spaces and cycle parking)
- Coach drop-off area within the car park
- Use of reinforced grass parking bays to minimise the urbanity of the car park surface
- Create a direct / off road pedestrian link between the car park area and the Earl's Palace


- Accommodate coach turning within the car park to allow restrictions to coach access along the fragile coastal road
- Consider the introduction of a new toilet block either within the proposed car park, or within the existing car park within the village.
- Introduce screen planting between the new car park and the St Magnus House garden.
- Incorporate a gated access into the adjacent field for agricultural use.
- Retain existing parking within the village centre, accommodating spaces for disabled drivers.



## Field to East of Earl's Palace - Coach Turning Area

This sketch focuses on the introduction of a coach turning facility within the field which lies to the east of the Earl's Palace. It also proposes enlargement of the existing village centre car park as described for Plan 1


- Introduction of a coach turning area using part of the field to the east of Earl's Palace
- Restriction to coach access beyond the new turning head to protect the fragile coastal road and relieve congestion.
- Extension of the existing village centre car park and proposals as Plan 1.



# Field to North-West of Earl's Palace - Coach Turning Area

This sketch focuses on the introduction of a coach turning facility within the field which lies to the north-west of the Earl's Palace, at the south end of the coastal road. It is intended to restrict coach access along the fragile and narrow coastal road.

- Adaption of the existing bend to form a turning head
- The new turning head would utilise part of the field to the north-west of Earl's Palace (south of the field boundary wall)
- Restriction to coach access beyond the new turning head to protect the fragile coastal road and relieve congestion
- Increase the width of the main road to 6m and introduce a footway from the coach turning / drop off area to the Earl's Palace
- Introduce coastal road 'gateway' and road narrowing at the northern edge of the turning head demarcating the limit of coach access
