1. Apologies

Resolved to note that apologies for absence had been received from David L Flett and Cathleen A Hourie.

2. Adoption of Minute

The Minute of the Meeting held on 14 March 2022 was approved, being proposed by Moyra Gordon, and seconded by Lorraine Craigie.

3. Matters Arising

A. Seatter Bridleway – Removal of Fencing

The Clerk had not yet received a response from Orkney Islands Council regarding the request to remove redundant fencing at the Seatter Bridleway, and it was:

Resolved to note the position.

Post meeting note – following the meeting the Clerk received a response which stated that an officer had walked about 200m down the path from Berstane Road end and did not see any old fencing wire. As mentioned previously, planning permission was given for the land at the end of the bridleway, which was now fenced off and construction started.

The response also referred to the query regarding funding for upgrading the core path from Inganess to Scapa and the use of sheep's wool. Funding options for K14 – Inganess to Scapa Bay were being looked at. The sheep wool floating path was more suited to peat bogs, as the path still required to be edged, with aggregate transported to the site. For the specific site in question, new plastic boardwalks were a better alternative and easier to work with.

B. Bag the Bruck

The Clerk confirmed that two applications had been received, from the Rotary Club and the 1st Kirkwall Company Boys Brigade, for assistance towards Bag the Bruck events, and it was:

Resolved to note that the Clerk would arrange for the grant to be paid out.

C. Financial Assistance – Notes of Thanks

The Clerk had received emails from Orkney Folk Festival, L Kemp (U17 and U13 Netball) and Orkney Amateur Swimming Club thanking the Community Council for financial assistance granted towards various events and competitions, and it was:

Resolved to note the correspondence.

D. Doorway in Broad Street

As C Hourie was not present, no update was provided in respect of the condition of a doorway in Broad Street, Kirkwall.

Post meeting note – C Hourie had spoken to staff at Virgin Money who confirmed the doorway was their responsibility. Their Clerk of Works had taken photographs in 2021 when in Orkney and submitted a request to their Estates section for a like-for-like replacement. As the doorway was in a conservation area, it was suggested that contact be made with the Council's conservation officer to determine whether a like-for-like replacement was possible, following which the appropriate action would be progressed.
