1. Apologies

Resolved to note that apologies had been received from Mr S Thompson.

2. Adoption of Minutes

The minute of the meeting held 10 June 2021 was approved, being proposed by Mr N Rendall and seconded by Mrs F McNab.

The minutes of the special meetings held on 6 and 18 August 2021 were also approved, being proposed by Mr N Rendall and seconded by Mr A Hourston.

3. Matters Arising

A. Ferry Issues - Questions and Answers

Members discussed the meeting between OIC officers, Stantec and the Community Council. The feeling of members was that Stantec was basing much of the ferry proposal for Papa Westray on the Western isles, where the current arrangements they have were working. Members were disappointed with the level of understanding from the consultants and believed that more accurate information was needed to be documented and solely based on the requirements of Papa Westray. Members felt that Stantec were not taking on the views and opinions from the local folk and members regarding the change of request from Link span to hard ramp via Westray following better understandings and new information received regarding the haulage for Papa Westray.

Members also felt that, at the present moment, with the current issues of transporting cattle, skips and at one time the fuel bowsers, Papa Westray was currently in a worse situation than before. Members were concerned that following the consultations, Stantec had advised residents of Papa Westray that the island would not be worse off.

Members also discussed the change in policy for transportation of loose cattle, and it was:

Resolved:

- 1. To request a copy of the report once generated by Stantec and published.
- 2. To note that members were disappointed with the lack of correspondence from Orkney Ferries with regards to changing of their policy for loose cattle on board and not notifying Papa Westray residents in writing.

B. Papay Water Scheme - Update and Improvements

Following consideration of the update received by the Clerk regarding the successful application for funding through CDF for the improvements, it was:

Resolved to note the information provided.

C. Community Resilience - Satellite Phone Funding

After consideration of the update from the Clerk regarding the tariff fees for the satellite phone and that correspondence had been received from the NHS enquiring about the costs involved, it was:

Resolved that no decision had been confirmed as to whether the NHS would be contributing towards the running cost of the satellite phone.

D. Fibre Broadband Proposal Update

Following consideration of the update from CloudNet regarding fibre and the current situation, it was:

Resolved to note the information

E. Kirkyard Road Repairs

After consideration of the update from the Clerk explaining that there had been no applications for tender submitted, it was:

Resolved that members would organise a temporary fix to the road.

F. Ferry arrangements - Papa Westray to Westray route

Following discussion between members and Councillors about the current situation regarding the ferry crossing between Papa Westray and Westray, it was agreed that members had great concern for the school children of Papa Westray schooling in Westray with regards to the length of time they were being made to wait. There could be a wait of up to 40 minutes on board the vessel at Pierowall until the school bus arrives to take them to school. Members request that, should this be ongoing, there should be a school bus waiting to collect them as soon as the vessel docks and the children taken directly to school to enable them to utilise the school's facilities.

Members also wished to suggest that the proposed timetable for the winter period should factor in a normal school run for the week and should the weather deteriorate through the day, the skipper have the flexibility to schedule a service to return the children to Papa Westray to ensure safe return, as the previous skipper had done.

Following further discussion, it was:

Resolved that the Clerk send a business letter to Orkney Ferries, the Education department and Democratic Services with the above concerns from members regarding this service.

G. Adjustments - Community-owned Skip

Following consideration of the update from the Chair and Clerk regarding the current situation with the restrictions, it was:

Resolved that the Clerk send a letter to Orkney Ferries, via Democratic Services, requesting a skip be provided for Papa Westray's use until Orkney Ferries had the sufficient equipment to transport the skip belonging to the community council.

H. Storage of OIC Gritter and Salt

The Clerk advised that a potential solution regarding the storage of the gritter and salt had been offered to Orkney Islands Council, but no response had been received, and it was:

Resolved that the Clerk would send a follow up email to Democratic Services regarding the offer.

I. Insurance Policy 2021-2022

Members had requested that the current policy which included the wind turbine, should only cover public and worker's liability. The Clerk advised that no response had been provided, and it was:

Resolved that the Clerk would send an email to Democratic Services to request an update on progress with this matter.

J. Kirkyard Road Weed Killing

Following a verbal update from the Chair explaining that a weed kill treatment had been applied to the required area, it was:

Resolved to note the information.

K. Proposed Works - St Boniface Kirkyard

Following a verbal update received from the Chair and the correspondence from the Stone mason who had recently assessed the head stones in question, it was:

Resolved that the flat stones laying the length of the graves could be levelled and the standing head stones would need professional assistance from a stone mason to ensure all works were carried out to current regulations.

Resolved to note that currently there seemed to be a shortage of Doctors and Nurses and that Papa Westray Community Council were very grateful for the nurses serving Papay.
