Members discussed the proposed winter Sunday sailings and their wish to see the summer sailings to be extended. A proposed timetable for Sunday sailings had been forwarded to Orkney Ferries by members. Egilsay residents had indicated that it would be a benefit to them if the winter sailing at 16:05 from Tingwall arriving at Egilsay at 17:00 could be reinstated and that the 18:00 from Tingwall to Egilsay on a Saturday remain available on request.

Members also noted that at present if you wished to travel on the lunchtime boat from Tingwall to Egilsay it had to be booked before 17:00 the previous day unless it was on a Monday when it can be booked before 09:00 that morning. Also, it was noted that if a visitor/tourist had booked the lunchtime ferry to or from Egilsay a resident would be permitted to travel to/from their island of residence by piggy backing that booking, and it was:

1. To note that the proposed Sunday timetable and other issues had been forwarded direct to Orkney Ferries.

2. That a request should be forwarded to Orkney Ferries asking if bookings can be made before 09:00, for the lunchtime sailing, to and from Egilsay on the day of travel and, if not, a response as to why it is not possible.
