Members received correspondence requesting a Bus Shelter to be placed at the top of St Margaret's Road and suggesting that an existing shelter which was not being used could be moved, and it was:

Resolved to ask Orkney Islands Council if the bus shelter near Bankburn House could be relocated.

## **B. Netball Orkney**

Members considered applications for funding towards the costs of travel to Glasgow to attend trials for the U17 and U19 Scottish Netball Squads for two members of Netball Orkney. The applicant had also enquired if the policy of limiting donations to two per person in each financial year would be continued, and it was:

#### Resolved:

- 2. That the limit of two donations per person should remain.

# C. St Mary's Trust Bulb Planting
