1. Presentation by the Local Engagement Manager, Warmworks, Scotland

Following a presentation from the Local Engagement Manager, Warmworks Scotland, at which members were informed of Warmworks area-based scheme in Orkney, it was:

Resolved:

A. To note the information provided by the Local Engagement Manager, Warmworks Scotland.

B. That assistance had been given in identifying a possible venue for a public presentation on the support, advice and availability on energy efficiency available from Warmworks Scotland.

The Chair thanked the Local Engagement Manager for the presentation.

The Local Engagement Manager left the meeting at this point.

2. Village Play Park

Members heard that a request had been made for this item to be placed at the start of the agenda to allow a representative from OIC Sport and Leisure to attend, but that unfortunately the officer was now unable to attend, and it was:

Resolved:

A. To note the information.

B. That a further meeting would be arranged to allow a representative from OIC Sport and Leisure to discuss with members previously raised issues regarding the Village Play Park.

3. Apologies

Resolved to note that apologies for absence had been received from Mr D Stout and Mr S Weaver.

4. Adoption of Minute

The minute of the meeting held on 28 April 2021 was approved, being proposed by Mrs S Whiteman and seconded by Mr J Seaton.

5. Matters Arising

A. Bay Kirkyard

Members heard that a newly appointed Burial Grounds Officer was now in post and that it was hoped an update would be provided shortly on members' request for the ground to be levelled in the Bay Kirkyard, and it was:

Resolved to note the information.

B. Stronsay Plastic Recycling Trial – Final Report

Members heard that the Waste Section had produced a summary report on the Stronsay Plastic Recycling Trial and that this had been made public, and it was:

Resolved to note the information.

C. Orkney Ferries - Sunday Sailings and On-Line Bookings

Members heard that the queries raised by members over Sunday sailings and the implementation of the online booking system had been addressed by the Ferry Services Manager, and it was:

Resolved to note the information.

D. Vat O' Kirbuster Bench

Members heard that the bench had been positioned at the Vat O' Kirbuster, and it was:

Resolved to note the information.

6. Ferry Fares

Members heard that Orkney Islands Council had been allocated additional funding from the Scottish Government to fully cover the costs of operating internal ferry services during this financial year and, as a consequence, a new fairer ferry fares structure had been implemented, and that communities would be consulted on future fare structures, before February 2022, and it was:

Resolved to note the information.

7. Stronsay Slaughterhouse Report

Members heard that Community Council volunteers had undertaken a general external clean-up of the slaughterhouse and surrounding ground, and that the quarterly hydro bill for the period 9 February to 12 May 2021 had been paid, and it was:

Resolved to note the information provided.

8. Fish Mart Report

Members heard that the Works and Inspection Manager had given a detailed response to issues raised on improvements to the Fish Mart's heat loss from the Café's vaulted ceiling and that the Building Inspector would be issuing instructions to get the other repair works done. Uncertainty remained over the internal redecoration, an Electrical Installation Certificate for the public coin operated shower had been issued and electrical testing of all the fixed appliances had taken place as well as a legionella risk assessment and disinfection of the ventilation system. Members also heard they had previously been consulted and agreed on repairs to the Café's deep

fat fryer and a replacement element and spare for the immersion heater. The Operator had provided details of dates between 20 September 2021 and 2 February 2022 when the Fish Mart Café would be closed, which was discussed in detail, a request for shelving in the freezer room on which to store salt for a water softener that was to be fitted, an air vent had been fitted in the freezer room and members heard a decision had not been given on who was responsible for cleaning the kitchen's cooker hoods. The six-monthly payment for cleaning and maintaining the public toilets had been made and the Operator had made arrangements for the Community Council to receive monthly direct debit payments for hydro use. Discussions had taken place with an Energy Efficiency Heat Advisor on the Fish Mart's heating, and advice and support requested on fitting low carbon or renewable technologies. An expression of interest in possible funding had been submitted and acknowledged and reports would now be written and presented to members, and it was:

Resolved:

- A. To note the information provided.
- B. That, if the Community Council was to be charged for the cleaning of the Café's cooker hoods, the work would be undertaken by the Chair, at no cost to the Community Council.
- C. That the Chair would meet with the Operator and discuss alternative opening arrangements for the Café to be open on dates between 13 December and Christmas.

9. Stronsay Development Trust – Co-opted Representative's Report

Members were given a verbal summary of the Stronsay Development Trust's recent activities and projects, and consideration was given to a request for a letter of support, from the Community Council, for the Development Trust's funding application for community ownership of the Stronsay Hotel, and to providing financial support for the haulage of waste from a beach clean, and it was:

Resolved:

- A. To note the information.
- B. That members agreed a letter of support should be written endorsing Stronsay Development Trust's funding application for community ownership of the Stronsay Hotel.
- C. That members agreed to finance the haulage of waste, up to £300 and subject to Community Council Grant Scheme approval, for a beach clean to be organised by Stronsay Development Trust.
- D. That the Community Council Co-opted Stronsay Development Trust Representative would confirm details of the beach clean up before Community Council Grant Scheme funding was applied for.

10. Transport Representative's Report

In the absence of the Transport Representative, members heard that the Air and Ferry Transport Forums had been held earlier in the day and that the Transport Representative had emailed members to confirm the minute from the previous Air Transport Forum, and the next timetable, had been approved, and that more information would follow on the Ferry Transport Forum, and it was:
