# 1. Apologies

# 2. Adoption of Minute

A notice had been displayed locally giving details of the Ferry Services Manager's response."

"Members heard that they had previously been consulted over a request from the Roads Support Manager regarding an upgrade to the flood barrier at the opening to the west of the Fish Mart, and it was:

Resolved that members were in agreement with the installation of a new barrier system. at the opening to the west of the Fish Mart."

# 3. Matters Arising

# A. Village Play Park

Members heard that two outdoor play equipment brochures were still circulating between members, and it was:

# **B. Stronsay Roads Depot and Recycling Centre**

Members heard that there had been no objection from Stronsay Development Trust to relocating the recycling containers from the Roads Depot to Wood's Yard, and it was:

Resolved to note that Stronsay Development Trust had no objection to the recycling containers being relocated to Wood's Yard and that Orkney Islands Council would be notified of this.

# C. Bay Kirkyard:

Members heard that their request for the levelling of the uneven ground in the Bay Kirkyard had been forwarded for attention, and it was:

## D. Ferry Cafeterias

Members heard that there had been no response from the other North Isles Community Councils asking for their opinion and comments on the non-availability of a cafeteria service on the inter-island ferries, and it was:

## E. Telecare and Mobile Responder Service

Members heard that their objection to the levying of a £3.50 a week user charge for the Telecare and Mobile Responder Service had been forwarded to Orkney Island Council and that the proposed charge was not approved and would be the subject of further debate in 2021, and it was:

## F. Slippery Pavement

Members heard that the Roads and Environmental Services Operations Manager had put out an instruction for the slippery pavement in Whitehall Village to be power washed, and it was:

#### G. Rothiesholm Beach Car Park

Members heard that repair work had been approved to the Rothiesholm beach car park, that this should commence after March 2021 and that investigations would take place on whether a drainage ditch was required, and it was:

- 3. That Democratic Services would be asked to forward members' request to the North Isles elected members.

Resolved to award the Stronsay Heritage Committee £91.30 to purchase nine Orkney View ring binders, subject to Community Council Grant Scheme approval.
