## 1. Apologies

Resolved to note that apologies for absence had been received from Councillor H Woodbridge.

## 2. Adoption of Minutes

The minute of the meeting held on 5 December 2022 was approved, being proposed by Rev D Locke and seconded by Mr S Hourston.

## 3. Matters Arising

## A. Village Play Park

Members heard that the Sport and Leisure Service Manager had forwarded the current Play Area Strategy for Orkney, guidance notes and an application form for the Play Park Equipment Renewal Fund, and it was:

Resolved that this item would be carried over to the next meeting.

### **B. Scrap Vehicles**

Members heard that four vehicles were still waiting to be removed, all having expired the two months given for owners to arrange disposal, and it was:

Resolved that the owners would be notified that they had until the 17 February 2023 to arrange removal of the vehicles under the Scrap Car Scheme after which time any remaining would be removed from the scheme.

## C. Nolan Principles Adoption Proposal

Members heard that on reflection there was no need for further discussion on the Nolan Principles adoption, and it was:

## D. Haulage of Aggregates

Members considered applications received for financial assistance towards the haulage of aggregates for use in improving roadways leading to an occupied residence, and it was:

Resolved that the successful applicants would be notified of the grants to be awarded for the haulage of aggregates and how to claim these.

# E. Response to Shapinsay Community Council Letter to Isles Community Councils

Members heard that three responses had been received from residents giving details of their experiences of specific problems when using Orkney Ferries, and it was:

Members heard that enquiries were on going into the new telecom tower, and it was:

# 4. Slaughterhouse Report

Members heard that an invoice from the electricity supplier covering the period 7 October 2022 to 6 January 2023 had been received, as well as a letter advising the slaughterhouse was not eligible for the Energy Bill Relief Scheme, that details of the Non-Domestic – Revaluation 2023 had also been received, and that the chopping boards had been power washed, and it was:

Resolved to note the information provided.

## 5. Fish Mart Report

Members heard that the two wall mounted ashtrays had been approved, purchased and fitted, and that the Operators' Agreement had been signed and was in place for a further twelve months. It was also reported that Orkney Islands Council Cleaning Specification and Audit Inspection Guidelines had been received and forwarded to members and the Operators, the television licence had been renewed and, following a consultation process, members had agreed to ask an outside contractor to clean the hostel carpets, which had received Community Council Grant Scheme funding. Consideration was given to the building's fire evacuation plan which members were told was their and the Operators responsibility to agree, the completion of previously

identified remedial work, a request for public toilet signs for the Fish Mart and pier toilets, and of changes to the broadband and telephone account, and it was:

#### Resolved:

- A. To note the information.
- B. That the Head of Property, Asset Management and Facilities would enquire and forward information from Health and Safety Law on a fire evacuation plan.
- C. That the Head of Property, Asset Management and Facilities would raise the issue of outstanding work still to be completed with a work colleague.
- D. That a request would be made for Orkney Islands Council to install public toilet signs at the Fish Mart and Pier waiting room.

# 6. Reports from Representatives

### A. Transport Representative

Members heard that the Transport Representative had attended the Air Service Consultative Forum meeting on 17 January 2023 where the need for a third aircraft and the trial of an electric powered aircraft were mentioned. On the same day, at the Ferry Service Consultative Forum meeting, the aging ferry fleet and the need for replacement ferries was discussed and a request was made for local support for new ferries, and it was:

- 2. That the Transport Representative would follow up the possibility of raising the profile of Orkney's need for new ferries with a television producer.
