1. Apologies

Resolved to note that apologies for absence had been received from L Martini-Brown and Mr J Seaton.

2. Adoption of Minutes

The minute of the meeting held on 20 March 2023 was approved, being proposed by Mr S Hourston and seconded by Mr P Riley.

3. Matters Arising

A. Village Play Park

Members heard that a funding application had been submitted to the Orkney Islands Council Play Area Renewal Fund. This had received support subject to further financial information being submitted which had since been provided, and it was:

Resolved to note the information provided.

B. Scrap Vehicles

Members heard that the scrap car scheme had been reopened for a further ten vehicles and advertised accordingly. Three spaces remained and attempts had been made to secure payment from Orkney Aggregates for vehicles delivered for scrap, and it was:

Resolved to note the information provided.

C. Shapinsay Community Council Letter

Members heard that there had been no response to requests for feedback on contact made with a BBC journalist and presenter in the reply letter sent to Shapinsay Community Council on concerns raised over Orkney Ferries, and it was:

Resolved that a further request would be made for feedback on any contact made with a BBC journalist and presenter regarding concerns raised over Orkney Ferries.

D. Orkney Ferries – Draft Timetables 2023/2024

Members heard that copies of the draft Orkney Ferries timetables for 2023/2024 had been circulated and that any feedback on these would be raised by the Transport Representative at the next Air and Ferry Services Consultative Forum meetings, and it was:

Resolved to note the information provided.

E. Orkney Health and Care Update

Members heard that the Chair and Vice Chair had continued to attend online meetings regarding Orkney health and care issues and that Community Councils had been asked to elect a Health and Care representative to represent their area in any relevant discussions with a wider group, and it was:

Resolved:

1. To note the information provided.

2. That Mrs S Whiteman would be the named representative to represent Stronsay in any relevant discussions with IJB/NHSO.

F. St. Catherine's Bay Core Path

Members had previously been forwarded a response to their request for an inspection and improvements to the core path leading to St. Catherine's Bay and to the kissing gate at the parking area to St. Catherine's beach, and that following this a member had reported all appeared to be well, and it was:

Resolved:

1. To note the information.

2. That no further action was needed to remedy issues previously raised.

G. Platinum Jubilee Presentation Packs

Members heard that the two remaining platinum jubilee packs had been distributed to the first two children born after the platinum jubilee celebration, and it was:

Resolved to note the information.

H. Christmas Light Decorations

Members considered previously circulated information on Christmas light decorations, and it was:

Resolved that no further action would be taken to purchase, install or maintain Christmas light decorations.

I. Coronation

Members heard that Community Council Grant Scheme funding had been approved for the purchase of Coronation First Day Covers, that these had been distributed to every resident child aged sixteen and under, that a parent had written on behalf of his child to thank members for the Coronation First Day Cover. Following consideration on how to distribute the remaining five covers, it was:

Resolved:

1. To note the information provided.

2. That two Coronation First Day Covers would be donated as raffle prizes to the Stronsay Massive Weekend, that one would be given to a child born on Stronsay and was currently visiting the island and the remaining two would be given to the next two babies to be born.

J. Bag the Bruck

Members heard that there had been no expressions of interest received in Community Council sponsorship for this year's Bag the Bruck event, and it was:

Resolved to note the information.

K. Electric Vehicle Charging Points

Members had previously been consulted about two locations for electric vehicle charging points and that these had been forwarded to the Community Council Liaison Officer, and it was:

Resolved:

1. To note the information.

2. That members' enquiry into the installation of electric vehicle charging points in Stronsay would be pursued.

L. Stronsay Map

Members heard that no further information was available on replacing the maps of Stronsay currently located at various locations throughout the island, and it was:

Resolved that Mr P Riley would enquire into replacement maps for those currently on display at various locations throughout the island.

M. Awards for Local People

Members had previously been emailed information from the Lord-Lieutenant of Orkney on awards for local people which included details of a scheme used in another authority, and heard that that it was believed discussions had taken place with two of the North Isles Councillors about an award scheme for local people, and it was:

Resolved:

1. To note the information provided.

2. That a request would be made for an update on discussions that had taken place on recognising those who have made a significant contribution within their communities.

4. Stronsay Resilience Plan

Members had previously been consulted about changes to the Stronsay Resilience Plan and heard that the plan had then been updated and displayed locally, and would be updated in a year's time, and it was:

Resolved to note the information.

5. Daffodils on Verges Proposal

Members considered a proposal for the Community Council to purchase daffodil bulbs and issue these free of charge to residents to plant on a verge in front of their property, and it was:

Resolved:

A. That members agreed to the purchase of three, twenty-five kilogram nets of daffodils to be issued free of charge to residents to plant on a verge in front of their property, subject to Community Council Grant Scheme approval.

B. That the Clerk would organise the purchase and distribution of daffodil bulbs.

6. Slaughterhouse Report

Members had previously been consulted about the purchase of a new hoist for use in the slaughterhouse as attempts to repair the existing one revealed additional faults that could be uneconomical to repair. A new hoist had been identified and members agreed to contribute towards this from existing funds and to an application being submitted to Community Led Local Development funding by the Empowering Communities Liaison Officer on the Community Council's behalf, with a decision being given in September 2023.

Members heard that a repair was needed to the slaughterhouse door and Mr D Stout offered to undertake this once the Clerk had supplied the necessary fitting.

The Orkney and Shetland Valuation Joint Board had issued a valuation on the property, and this would be forwarded to Orkney Islands Council.

Two invoices had been received from the electricity supplier; these covered the period 18 January 2023 to 6 July 2023. Compensation had also been received from the electricity supplier for a disruption to service, and it was:

Resolved:

A. To note the information.

B. That enquiries would be made into the possible availability of a hoist from the Kirkwall abattoir and a mainland butcher.

7. Fish Mart Report

Members heard that a fire evacuation plan was still needed for the Fish Mart and that a fault had occurred in the washing machine necessitating a new replacement machine being issued, free of charge, by the manufacturer.

Members had previously been consulted and agreed to the Operators' request for new equipment which they had ordered and were reimbursed for, but the Operators' request for an increase in the hostel bed charges was declined, with members agreeing to this being reviewed in the new year. A new inventory had been written and further communication was awaited from the telephone and broadband supplier on changes being made to their intention to cease providing a service.

The Operators' quarterly payment for cleaning and maintaining the public toilets had been made and a local contractor had been paid for carrying out an essential repair to in item of equipment used in the Café kitchen, but other repairs, authorised and arranged by officers within Orkney Islands Council, had still to be completed.

A letter had been sent to the Operators reminding them of the Operators' Agreement in force since 1st January 2023, and it was:

Resolved:

A. To note the information.

B. That Mr D Stout would enquire about a fire evacuation plan for the Fish Mart.

C. That a request would be made for all outstanding issues be attended to as a matter of urgency.

8. Reports from Representatives

A. Transport Representative

Members heard that the Transport Representative would raise any issues brought to his attention regarding Orkney Ferries or Loganair at the next Transport Forum meeting due to be held on 13 September 2023, and it was:

Resolved to note the commitment from the Transport Representative.

Members had previously been provided with details of two planning applications, one for the erection of a house with detached garage on land near Whitehall Farm and the other for a change of use of land from agricultural to domestic use, neither evoking comment, and it was:

Resolved to note the information provided.

A. Winter Service Plan

Members had previously been consulted on the Winter Service Plan 2023/2024 and although the deadline for comments had passed, the Clerk was asked to request an alteration to the gritting schedule to extend this to include gritting on the unclassified road to Linksness rather than end at Rosebank on the B9062, where turning the gritting vehicle was difficult, and it was:

Resolved that a request would be made to extend the gritting schedule to end at Linkness rather than end at Rosebank on the B9062.

B. Orkney Islands Council (Variable 20mph Speed Limit) (Island Schools) Order 2023

Members had previously been consulted and responded to the Consultation – 20mph Speed Limits Island Schools, this was being taken back to committee and members were being asked to confirm whether or not they were in favour of a part-time 20mph speed limit within the vicinity of the island schools, and it was:

Resolved:

A. That members of Stronsay Community Council supported the introduction of a 20mph part-time speed limit within the vicinity of the island schools.

B. That on Stronsay road signs for the 20mph part-time speed limit should be positioned where the current 40mph speed restriction signs are on the north and south side of the school.

I. Rothiesholm Car Park Rubbish

Members had previously been consulted about the removal of rubbish deposited at the Rothiesholm car park and the liaison that had taken place with the Community Development Officer and Orkney Islands Council regarding this, and it was:

Resolved to note that the Clerk had re bagged and removed most of the rubbish and arrangements were in hand for this, and heavier items of rubbish left in the car park, to be taken into Kirkwall.

M. Pier Mess

Members had previously been consulted about poor state of the weighbridge bollards, rubbish that had been left around the Harbour master's Office and the overflowing recycling container at the head of the pier. These had been brought to officers' attention and the Port Safety Manager was aware of the situation and would talk to his team to have new bollards fitted at the weighbridge and arrange for the rubbish to be moved as soon as possible. Members heard that the recycling container had been emptied but the fly-tipped rubbish remained, and the weighbridge bollards were yet to be replaced, and it was:
