### **Town and Country Planning (Scotland) Act 1997 (as amended) Section 64, variation of planning permission**

The planning authority may approve the variation of the planning permission if it appears to the planning authority that the variation sought is not material.

Note that if a proposed variation is considered material, the request for a non-material variation may be refused. In such cases a new planning application would be required for the variation. Further guidance is provided by Development Management.
