Is the function/policy/plan new or existing? (Please indicate also if the service is to be deleted, reduced or changed significantly)	This assessment relates to a review of the fares and tariffs for internal ferry services charged by Orkney Ferries Limited and the introduction of smart cards.	

2. INITIAL SCREENING	
What are the intended outcomes of the function/policy/plan?	 The introduction of a revised tariff structure that: achieves fairness, consistency and openness in terms of availability of tariffs; assists in addressing social exclusion to islands communities; and assists in promoting social and economic development The introduction of smart cards, on a phased basis, starting with those eligible for concessionary travel under the Council's existing scheme on 1 April 2012.
State <i>who</i> is, or may be affected by this function/policy/plan, and <i>how</i>	All users of the internal ferry network – both domestic and commercial may be affected by this review. However, at the time of undertaking this assessment it is not possible to undertake a finalised equality impact assessment pending the outcome of further consultation. This assessment will consider the groups

most likely to be affected based on the alternative tariff models being considered by the Council and will be updated following further consultation. The proposed introduction of smart cards will affect those eligible for concessionary travel with effect from 1 April 2012. It will be more convenient to the user and enhance confidentiality. How have stakeholders been Revised models have been the subject of public involved in the development of consultation, including public meetings held within this function/policy/plan? each island community council area. Questionnaires were available on line, at each public meeting and distributed to island rural shops. A separate meeting was held with the Orkney Equality Forum who submitted their own response to the consultation. The recommendations to the Transport and Infrastructure Committee on 28 February 2012 is to consult on two refined models (taking account of feedback from consultation). These two revised models, along with the current tariff model will be the subject of a second round of consultation. The review included a comparison and reports, benchmarking (see benchmarking of ferry tariff structures of other Scottish equalities resources on OIC information portal) operators and consideration of other European models. The study included a summary of available evidence on the impact of different charging regimes for ferry services in delivering social and economic benefits to isles communities. An equality impact assessment was undertaken as part of the study and is available as appendix 5 to item 1 on the reports accompanying the agenda for the meeting of the Transportation and Infrastructure Committee held on 6 September 2011. 6. Age: people of different ages	Yes – children 5-15, students, those aged over 60 are offered discounts.
	Passengers are currently able to purchase 10 and 20 journey books of tickets, which offer 25% and 30% discounts on the standard passenger tariff respectively. Passengers who live in the isles are able to purchase 50 journey books of tickets offering a 50% discount on the standard tariff. These tickets must be bought in advance and hence there may be issues of affordability for those on low income. This includes students and people of pension age. Both Options 1 and 2 would have positive impacts for those aged over 60 and students residents on the islands who are unable to afford to purchase multi journey tickets. The standard islander fare will be reduced for all other than those who purchase 50 book of tickets who currently receive a 50% discount. Negative impacts Those aged over 60 who are not island residents would no longer receive a 50% discount on the adult fare.
7. Religion or beliefs or none (atheists)	No
8. Caring responsibilities	Yes. Positive - the Council under its concessionary travel scheme offers residents of the isles who are older or who are disabled, 12 free return trips per annum on Orkney Ferries services. In addition, those with a Blue Badge also receive 12 free return trips for a vehicle, and those with a C+1 entitlement are able to bring a companion with them free on the 12 return trips. The report recommends no change to the current scheme.

10. Disability: people with	Yes the current tariffs offer discounts to registered

disabilities (whether registered or not)	disabled people, which includes free travel for registered blind people. The discount applies to both passenger and domestic vehicle travel. Both Options 1 and 2 remove the discount. The greatest impact will be on non island residents and to a lesser extent registered disabled island residents who will receive an islander discount.

Does the analysis above identify any differential impacts which need to be addressed?	Yes there may be an impact on younger and older people, people with disabilities and carers as detailed above in respect of the revised tariff structure.
	The introduction of smart cards could potentially reduce the stigma that may be associated with certain concessionary fares and enhance confidentiality as no one else should be able to tell what fare a particular passenger has paid.
How could you minimise or remove any potential negative impacts?	The review and second consultation will seek to explore with the service users concerns about the potential changes.
