## 1. Apologies

Resolved to note that apologies for absence had been received from David L Flett and Christine E Harcus and Councillors Andrew Drever, Barbara Foulkes and Steven B Heddle.

#### 2. Police Scotland Matters

Resolved to note that there were no Police Scotland matters.

## 3. Adoption of Minute

The minute of the meeting held on 19 August 2019 was approved, being proposed by Moyra Gordon and seconded by Kim Burns.

Robert Leslie and Rikki Lidderdale joined the meeting at this point.

# 4. Matters Arising

### A. Shrub Bed at Scapa

After hearing an update from Cathleen Hourie regarding potential funding for clearing and replanting the shrub bed at the Scapa junction, it was:

Resolved to note that a response was still awaited from Robertsons.

### **B. Traffic Issues at Watersfield Development**

After hearing an update from Councillor David Dawson regarding proposals for a public meeting to consider ongoing traffic issues within the Watersfield housing development, it was:

Resolved to note that a public meeting covering issues raised by residents within the Watersfield housing development would be held on 6 November 2019 in the Sound Archive, Laing Street, Kirkwall.

# C. Bridle Path at Inganess

After hearing an update from the Clerk on behalf of Councillor B Foulkes regarding a request to cut back bushes on the core path below Wideford Farm, it was resolved:

- 1. To note that path K14 from Inganess Bay to the A961 was covered by ground maintenance, with the type of management being strimmer only.
- 2. To note that the path was inspected in June, and issues identified resulted in some branches being cut back in the vicinity of Caldwell Cottage and some sections along the path near Wideford Farm, as part of furniture (stiles, gates and boardwalks) maintenance and drainage improvements.
- 3. To note that maintenance of structures was prioritised over drainage which in turn was prioritised over vegetation issues outwith the grounds maintenance contract.

- 4. That, following confirmation of the exact section of the path which John R Mowat mentioned at a previous meeting, the Clerk should advise Orkney Islands Council accordingly, so that any necessary works could be carried out.
- 5. That the Clerk would chase up the outstanding works on the damaged boardwalks initially identified by Robert F Leslie and seek confirmation that the works had now been completed.

### D. Bonfire and Fireworks Display at Pickaquoy

Following consideration of the proposed Event Management and Contingency Plan for the event, copies of which had been circulated, and after hearing a report from the Clerk on matters raised at the most recent meeting of the Bonfire Committee, it was resolved:

- 1. To approve the Event Management and Contingency Plan, as submitted.
- 2. That the Community Council should meet 50% of the total cost associated with the Red Cross attending the event, currently £300 plus VAT.
- 3. That Community Councillors and Elected Members should advise the Clerk whether they would be available to assist with stewarding the event on the night, or to watch the bonfire from 12 noon.

#### E. Timetable for Headstone Reinstatement

Following consideration of correspondence from Orkney Islands Council setting out a timetable for reinstating headstones in various kirkyards in Orkney, copies of which had been circulated, it was:

Resolved to note that works to reinstate headstones in St Olaf's Cemetery and the Cathedral Kirkyard were due to be completed by 9 October and 26 November 2019 respectively.

# F. Community Wind Farm – Community Benefit

Following consideration of correspondence from Orkney Islands Council regarding potential community benefit from the Community Wind Farm project, copies of which had been circulated, it was:

Resolved to note that a report on the guiding principles and delivery mechanism options for community benefit was due to be considered by the Council's Policy and Resources Committee in September, with the report recommending that further community consultation be undertaken regarding location specific community benefit and Kirkwall and St Ola Community Council is to be a key consultee in that process.

Resolved to note the proposals affecting the Kirkwall East ward boundary near Kirkwall Pier and including an area around Kirkwall Airport, currently within the East Mainland, South Ronaldsay and Burray electoral ward.

Resolved to note the estimated balance as at 27 September 2019 of £6,956.96.

Resolved to note the balance remaining for approval of £0, with the capping limited exceeded by £95.60.

### **B. Orkney Gymnastics Club**

## A. Road Naming at Carness

Following consideration of correspondence from Orkney Islands Council requesting suggestions for a new road through a housing development off Carness Road, copies of which had been circulated, it was:

Resolved that the Clerk should provide the following suggestions to Orkney Islands Council:

- Robert Miller Road Robert Miller was a Kirkwall man who married in spite of the Press Gang (reference, Mackintosh WR, Around the Orkney Peat Fires (Ninth Edition)).
- Iceland Skerry View Iceland Skerry is a skerry situated in the near vicinity.
- Thunberg Road after Greta Thunberg, the Swedish teenage environmental activist on climate change whose campaigning has gained international recognition.

## **B. Town Centre Funding**

Following consideration of correspondence from Orkney Islands Council advising of potential town centre funding, copies of which had been circulated, it was resolved:

1. To note that the Council had received a capital grant allocation from the Scottish Government, amounting to £200,000, as part of the Town Centre Fund, to support economic investments which encouraged town centres to diversify and flourish.

- 2. To note that the grant funding must be committed by 31 March 2020, projects completed by 30 September 2020, and only projects in Kirkwall and Stromness town centres being eligible.
- 3. To defer consideration to the next meeting, to enable members to consider projects which might be eligible for the Town Centre Fund capital grant allocation.

### C. Scotland's National Transport Strategy

Following consideration of correspondence from Transport Scotland regarding consultation on the draft National Transport Strategy, copies of which had been circulated, it was resolved:

- 1. To note that Scotland's National Transport Strategy was currently open for consultation until 23 October 2019, with the NTS Engagement Team in Orkney on 9 October 2019.
- 2. That Moyra Gordon should attend the engagement event on 9 October 2019 to be held in the Kirkwall Town Hall.

### D. Closure of Peedie Breeks Nursery

After hearing representations from several members regarding the announcement that Peedie Breeks Nursery would be closing in July 2020, it was:

Resolved to note the current situation, including the assurance from Orkney Islands Council that alternative childcare provision would be in place by July 2020.

#### **E. Grounds Maintenance**

After hearing representations from several members regarding ongoing issues relating to grounds maintenance, including grass cutting and weed control, it was:

Resolved to note that, although alternative grounds maintenance regimes had been instigated, it would take some time for the right balance to be struck between regular cutting and leaving some areas to naturalise.

Resolved that the next meeting of Kirkwall and St Ola Community Council be held on 25 November 2019 in the Garden Room, King Street Halls, Kirkwall, commencing at 19:00.
