

Item: 4 Orkney Towns Board 7 February 2025 Engagement Report

1. Overview

1.1 The purpose of this report is to provide a brief overview of the meetings and engagement undertaken by the Orkney Town's Board during 2024. It includes a summary of OTB meetings, a record of consultation events, and a summary of the ideas generated through these consultations.

2. Recommendations

- 2.1. It is recommended that Orkney Towns Board:
 - i. Note the engagement work which has been undertaken to date, and the summary of the outcome of this work detailed in Appendix 1.

3. Background

- 3.1. The inclusion of an Orkney based programme as part of the UK Government's Levelling Up Towns Board Programme was announced by the UK Government in spring 2024. At that time, the UK Government had established a very challenging and urgent timeframe for progressing the engagement phase which was originally required to conclude by November 2024. The expectation at that time was that project funding would begin shortly thereafter.
- 3.2. Following the General Election in July 2024, the UK Government began a review of the Towns Board Programme. This review is not yet complete, with revised Guidance and timelines expected to be issued during the first quarter of 2025. In advance of publication of this revised guidance, the Government has confirmed that Towns Boards across the UK should plan for a longer period for development of a project programme, to run throughout financial year 2025/26; with the first year of project delivery funding to be expected from April 2026.
- 3.3. As noted above, the Towns Board began a rapid period of development work over the summer 2024. This included several Board meetings/workshop sessions and public engagement events.

3.4. Board meetings/workshops included:

- 10 June 2024 formal meeting of the Board which covered key OIC decisions, potential funding opportunities, deliverables and timescales, setting the groundwork for the work of the Board.
- ii. 25 June 2024 informal workshop which included discussion on the Vision and the range of community engagement activities which the Board were keen to progress over the summer.
- iii. July 2024 informal workshop which further developed the public engagement methodology and target outcomes.
- iv. 11 July 2024 formal meeting of the Board which included discussion on emerging Vision, draft proposals for public engagement and approval of Terms of Reference.
- v. 16 July 2024 informal workshop which focused on more detailed planning for the community engagement events. This included arranging workshop sessions, establishing communication channels and social media platforms, and developing strategies for indirect project idea collection.
- vi. 10 August 2024 Board member engagement as part of County Show stand.
- vii. 13 August 2024 informal Board meeting to discuss outputs from County Show and discuss next steps for public engagement work.
- viii. 3 September 2024 informal Board meeting which included updates from the Chair to Board Members regarding progress with engagement activities.
 - ix. 8 October 2024 informal Board meeting to discuss engagement outputs and revised guidance from UK Government.
 - x. 4 November 20024 informal Board meeting to discuss next steps following new UK Government Budget.
 - xi. 12 November 2024 informal Board meeting which focused on factual/ orientation briefing on engagement outcomes and emerging themes, in advance of workshop on 27 November 2024.
- xii. 27 November 2024 Board workshop to develop Vision Statement and draft Framework/sub-themes emerging from engagement process.
- xiii. 12 December 2024 Board Chair attendance at Scotland's Towns Partnership' Towns Board Chairs. Meeting.
- xiv. 16 January 2024 Board Chair attendance at Scotland's Towns Partnership' Towns Board Chairs' meeting (these will continue on a cycle every 5 weeks).
- 3.5. In addition to this series of meetings of the Board, there have been additional regular meetings (up to 2-3 meetings a month) of the Board Chair and two other Board members with the Council's Economic Development team members to oversee progress with project management and delivery.

- 3.6. The primary public consultation events which were organised to gather project ideas for the Board included the following:
 - i. July 2024 present Open project/idea registration via webpage/QR code.
 - ii. 2 July 2024 Board Chair presentation to Orkney Business Forum Core Group.
 - iii. 18 July 2024 King Street Halls three stage presentation/engagement event.
 - iv. 10 August 2024 County Show open forum.
 - v. 26 September 2024 presentation and engagement with Orkney Business Forum.
 - vi. 1 October 2024 Online workshop engagement event (this included good attendance from Isles based people).
 - vii. 17 October Board Chair meeting with HIE and Orkney Local Area Action Group representatives.
- 3.7. As a result of these engagement events approximately 800 project ideas and issues have been recorded. Each submission has been documented in a project database. This project database has provided a steer on the kind of issues and project ideas which consultees believe the Towns Board might consider. This represents an invaluable resource to support the Board in developing the 10-year vision and the 3-year investment plan.
- 3.8. The Council's Economic Development team has undertaken work to review the database to draw up key themes to present a Programme Framework which can be used to Structure the ongoing work of the Board. The Programme Framework is addressed in a separate report to the Towns Board.
- 3.9. Appendix 1 to this report provides a summary of the engagement database, linked to the Programme Framework and Sub-themes; and provides an overview of the key commentary for each sub-theme. This information will be used to support the development of the 10-year vision and 3-year plan.

Regeneration projects are also suggested, with some local clubs seeking to repurpose unused spaces, alongside ideas to refurbish the former Phoenix Cinema and Visitor Centre.
