1. Apologies

Free, confidential services, advice and therapies are offered by the charity, and they also operate a local refuge. Members heard that posts were funded by different organisations and, as funding from Orkney Islands Council had been cut this year, they would be looking for additional backing. Members also heard that the charity supported users in their choices in a non-judgemental way and currently received enquiries from all over the UK. Following the presentation, it was:
