## THE ORKNEY ISLANDS COUNCIL (VARIABLE 20 MPH SPEED LIMIT) (SCHOOLS IN KIRKWALL AND STROMNESS) ORDER 2005

The Orkney Islands Council in exercise of its powers under Section 84(1) and (1A) of the Road Traffic Regulations Act 1984 ("the Act"), and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- This Order may be cited as The Orkney Islands Council (Variable 20 mph Speed Limit) (Schools in Kirkwall and Stromness) Order 2005 and shall come into operation on the First day of October Two Thousand and Five.
- 2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament. In this Order the expression "vehicle" means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along a road whether or not by mechanical power.
- (a) No person shall drive or cause or permit to be driven any vehicle in any
  of the lengths of road specified in the Schedule to this Order at a speed
  exceeding:-
  - (i) twenty miles per hour at a time when such a speed limit is indicated by a traffic sign in accordance with Article 3(b) hereof; or
  - (ii) thirty miles per hour at any other time.
  - (b) Such an indication may be given between the hours of 7.30am and 5pm on Mondays to Fridays inclusive, and at no other time.

(a) Kirkwall Grammar School

Unclassified Garson Road, Stromness, from a point forty metres or thereby north of its junction with unclassified Hamnavoe, Stromness, to a point twenty four metres four hundred millimetres or thereby south of its junction with unclassified Cairston Road, Stromness, a distance of three hundred and forty five metres or thereby

(d) Stromness Primary School

C43 Back Road, Stromness, from a point forty two metres or thereby northnortheast of its junction with unclassified Grieveship Road, Stromness, to a point six metres six hundred millimetres or thereby northeast of the westmost corner of the property known as Garquoy, Back Road, Stromness a distance of three hundred and fifty seven metres or thereby
