






Service Performance KPIs

eDevelopment Submissions – Total number of submissions made each week through the ePlanning and eBuildingStandards portals since launch in 2016






ePlanning Trends – Comparison of KPI¹ Submissions for ePlanning by Week (New Planning Applications) for Period from 2020 to 2025

eBStds Trends – Comparison of KPI¹ Submissions for eBStds (New Applications) by Week for Period from 2020 to 2025










