

THE ORKNEY ISLANDS COUNCIL (VARIABLE 20 MPH SPEED LIMIT)
(STROMNESS PRIMARY SCHOOL) ORDER 2012

The Orkney Islands Council in exercise of its powers under Section 84(1) and (1A) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1 This Order may be cited as The Orkney Islands Council (Variable 20 mph Speed Limit) (Stromness Primary School) Order 2012 and shall come into operation on the First day of August Two Thousand and Twelve.
- 2 The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament. In this Order, the expression "vehicle" means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along a road whether or not by mechanical power.
- 3 (a) No person shall drive or cause or permit to be driven any vehicle in any of the lengths of road specified in the Schedule to this Order at a speed exceeding:-
 - (i) twenty miles per hour at a time when such a speed limit is indicated by a traffic sign in accordance with Article 3(b) hereof; or
 - (ii) thirty miles per hour at any other time.
- (b) Such an indication may be given between the hours of 7.30 a.m. and 5 p.m. on Mondays to Fridays inclusive, and at no other time.

SCHEDULE

Unclassified Hillside Road	From its junction with A965 North End Road in a northerly direction for a distance of 46 metres or thereby to a point 4 metres or thereby south of the access to the housing scheme at Greenvoe.
C11 Cairston Road	From its junction with A965 North End Roundabout in an easterly then northeasterly direction for a distance of 126 metres or thereby to a point 36 metres or thereby southwest of the access road to Market Green.
Unclassified Ferry Road	From its junction with A965 North End Roundabout in a southerly then southsouthwesterly direction for a distance of 376 metres or thereby to a point at the southeasternmost boundary of Ferry Road (West) Long Stay Car Park where the existing 15mph speed limit commences.
A965 North End Road	From a point 29 metres or thereby north of A965 North End Roundabout in a southerly direction to a junction with the roundabout and then from a junction with the roundabout in a westerly then southerly direction to a point at the southwesternmost boundary of the property known as Rosebank, 21 North End Road, a distance of 189 metres or thereby.
Unclassified Hillside Terrace	From its junction with unclassified Hillside Road in a westerly direction for a distance of 16 metres or thereby.
A965 North End Roundabout	That length of the A965 at the junction of A965 North End Road, C11 Cairston Road and unclassified Ferry Road being the entire circulatory carriageway of North End Roundabout, a distance of 68 metres or thereby.
