

THE ORKNEY ISLANDS COUNCIL (VARIABLE 20MPH SPEED LIMIT)  
(SCHOOLS IN KIRKWALL AND STROMNESS) (AMENDMENT) ORDER 2019

Orkney Islands Council in exercise of its powers under Sections 84(1) and (1A) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1) This Order may be cited as The Orkney Islands Council (Variable 20mph Speed Limit) (Schools in Kirkwall and Stromness) (Amendment) Order 2019 and shall come into operation on the Eighteenth day of March Two Thousand and Nineteen.
- 2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament. In this Order, the expression "vehicle" means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along a road whether or not by mechanical power.
- 3) a) No person shall drive or cause or permit to be driven any vehicle in any of the lengths of road specified in the Schedule to this Order at a speed exceeding:-
  - i. Twenty miles per hour at a time when such a speed limit is indicated by a traffic sign in accordance with Article 3(b) hereof; or
  - ii. Thirty miles per hour at any other time.
- b) Such an indication may be given between the hours of 07.30 and 17.00 on Mondays to Fridays inclusive, and at no other time.



- c) This Order, where its provisions conflict, supersedes The Orkney Islands Council (Variable 20mph Speed Limit) (Schools in Kirkwall and Stromness) Order 2005 which came into operation on the First day of October Two Thousand and Five, and accordingly paragraph (b) of the Schedule to the said Order shall be replaced by the Schedule to this Order.

## Schedule

- (b) Glaitness Primary School, Kirkwall
- (i) On the C40 Pickaquoy Road, Kirkwall, from a point thirty metres or thereby north of its junction with unclassified Peerie Sea Loan, Kirkwall to a point two hundred metres or thereby eastsoutheast of its junction with unclassified Pickaquoy Loan, Kirkwall, a distance of six hundred metres or thereby.
  - (ii) On the unclassified Peerie Sea Loan, Kirkwall, from its junction with C40 Pickaquoy Road, Kirkwall, to a point nine metres or thereby west of its junction with C40 Pickaquoy Road, Kirkwall, a distance of nine metres or thereby.
  - (iii) On the unclassified Muddiesdale Road, Kirkwall, from its junction with C40 Pickaquoy Road, Kirkwall, to a point fifteen metres or thereby southwest of its junction with C40 Pickaquoy Road, Kirkwall, a distance of fifteen metres or thereby and
  - (iv) On the unclassified Pickaquoy Loan, Kirkwall, from its junction with C40 Pickaquoy Road, Kirkwall, to a point ninety five metres or thereby southsouthwest of its junction with C40 Pickaquoy Road, Kirkwall, a



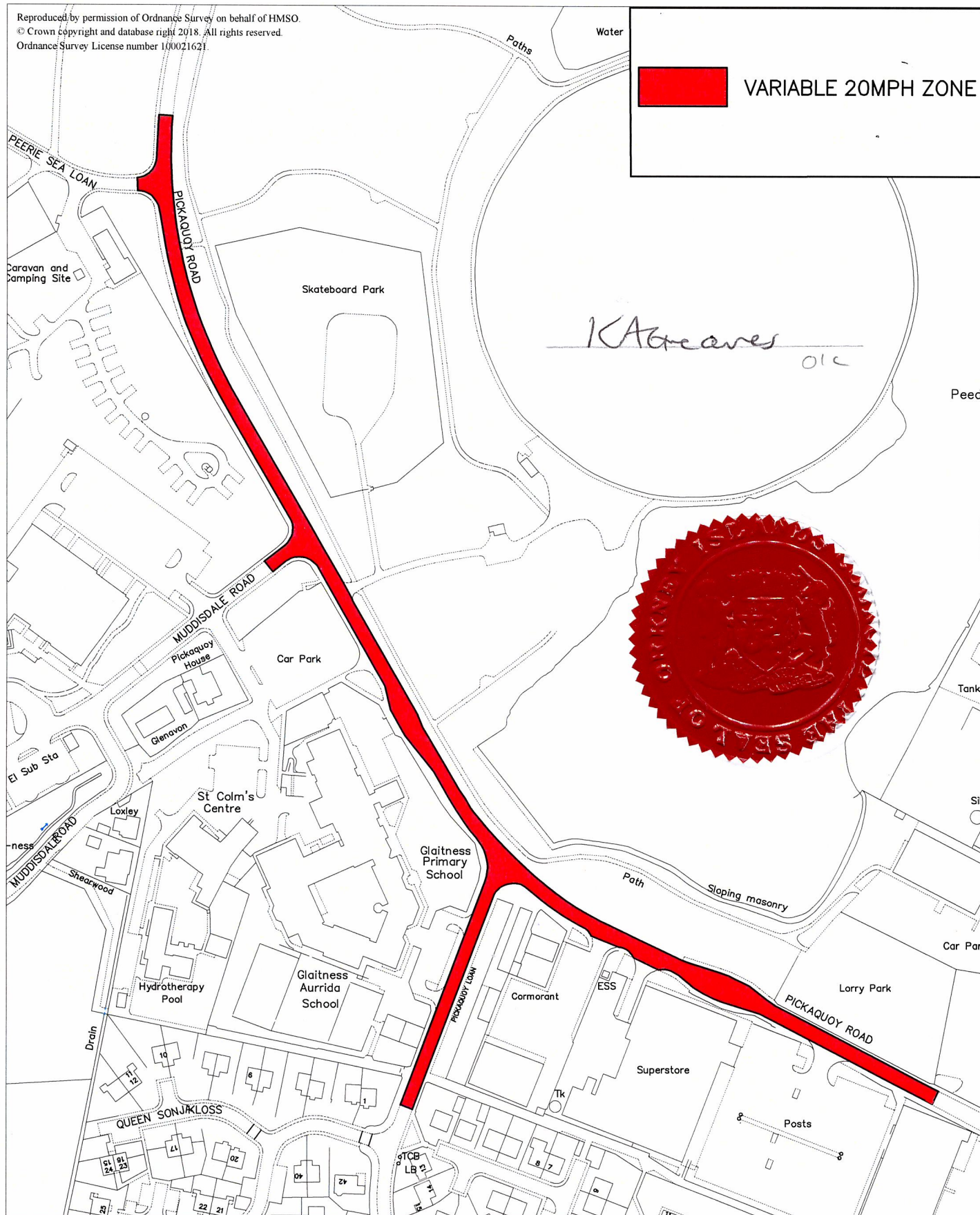
