## The Direct Debit Guarantee



- · This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits.
- If there are any changes to the amount, date or frequency of your Direct Debit, Orkney Islands Council will notify you 10
  working days in advance of your account being debited or as otherwise agreed. If you request Orkney Islands Council
  to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit by Orkney Islands Council or your bank or building society you are entitled to a full and immediate refund of the amount paid from your bank or building society.
  - If you receive a refund you are not entitled to, you must pay it back when Orkney Islands Council asks you to.
- You can cancel a Direct Debit at any time by simply contacting your bank or building Society. Written confirmation may be required. Please also notify us.

## How the information you have provided will be used

We need the information on this form, entitled 'Instruction to your Bank or Building Society to pay by Direct Debit', to process your request to make payment of Non-Domestic Rates by direct debit. The information is being provided with your consent.

The information may be shared as follows:

- Within the local authority to process your request for payment of Non-Domestic Rates by direct debit.

- Within the local authority to process any refund of any overpaid Non-Domestic Rates.
